## What is the CAC?

The CAC works with SELPA (Sonoma County Special Education Local Plan Area) to help address the needs of the special education community.

The CAC serves in an advisory capacity to the SELPA regarding community opinions, concerns, and suggestions pertaining to special education and related services to students with disabilities. The CAC strives for acceptance of learning differences and the importance of promoting accessibility in all areas of the community. The CAC believes classroom instruction should address all ability levels and learning styles. To achieve this, the CAC represents and supports the interest of children with disabilities, their parents, educators and our community.

## Who are we?

The CAC is composed of parents of children with special educational needs, educators, administrators, community members and representatives of other public and private agencies who are interested in providing quality education for children with special needs.

## What does the CAC do?

- > Increases parent awareness of changes in special education laws.
- > Informs parents of resources within our community.
- > Serves in an advisory capacity in the review and development of the Local Plan for Special Education.
- > Recommends annual priorities to be addressed by the SELPA.
- > Encourages community involvement in the development of the Local Plan.
- > Assists in parent education and recruitment.



## What is the goal of the CAC?

We recognize that placement in special education is the result of both the child's ability to learn, and the ability of general education to serve the child's needs. Therefore, it is imperative that general and special education forge a strong partnership, for each is an essential element of the other.

Our goal is to form a united educational community, so that children with learning difficulties can get the immediate intervention and continuing support they need, without losing the developmental, social and vocational benefits of a mainstream education.
